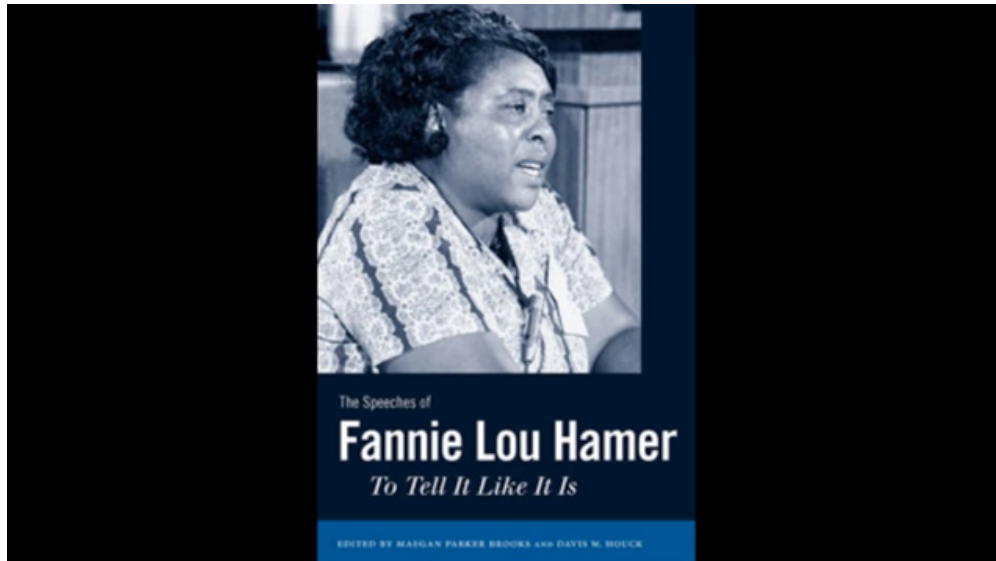

Miss. Commission Refuses Names For Negro Candidates

JACKSON, Miss. — (UPI) — Mrs. Fannie Lou Hamer, vice chairman of the Mississippi Freedom Democratic Party delegation which sought to replace the all-white regular Mississippi delegates at the recent Democratic national convention, and two other state civil rights workers, have been refused places on the ballot for the Nov. 3 general election, by the Mississippi State Election Commission, the Student Non-Violent Coordinating Committee has reported.
